The Rev. Dr. Mark A. Garcia (M.A.R., Westminster; Ph.D., Edinburgh) is Greystone's President/CEO, Fellow in Scripture & Theology, and Executive Director of the Anglican Studies Program. Dr. Garcia is also Associate Professor of Systematic Theology at Westminster Theological Seminary in Philadelphia, PA. Active in international ministerial and theological formation for over twenty years, Dr. Garcia is the author or contributor to many books, articles, and essays, and has long taught across the theological disciplines and in ministerial and theological mentorship.

The Rev. Dr. Lee Gatiss (Th.M., Westminster; Ph.D., Cambridge) is Director of the Church Society and formerly associate minister of St. Helen's Bishopsgate, London. Dr. Gatiss is also a member of the editorial board of The Global Anglican (formerly known as Churchman), serves on the Church of England Evangelical Council, and has written and edited over 30 books in Reformed Anglican history, theology, liturgy, and ministerial life, including editing *The Effective Anglican: Seizing the Opportunities of Ministry in the Church of England* (Church Society, 2015).

Rev. Canon Henry Jansma (M.A.R., Westminster; Ph.D., Durham) has lived in the United States and in England. Prior to planting All Souls Anglican in 2014, Henry also served in the Church of England (1991-2001) and the Episcopal Church (2001-2013). Canonically resident in the Anglican Diocese of the Living Word, Anglican Church in North America (ACNA), he also serves as Canon Theologian for the Diocese.

The Rev. Dr. Mark Earngey (D.Phil., Oxford) is Head of Church History at Moore Theological College and a Presbyter in the Anglican Church of Australia (Diocese of Sydney). Dr. Earngey is a highly respected and widely recognized scholar of the history and theology of the English Reformation, author of academic and popular resources in Anglican identity and Reformational traditions of worship, and has a special affection for parish ministry. Among his publications is (with Dr. Jonathan Gibson) *Reformation Worship: Liturgies from the Past for the Present* (2018).

Dr. Jake Griesel (Ph.D., Cambridge) is Lecturer in Church History and Anglican Studies at George Whitefield College, Cape Town, a Research Associate at North-West University's Faculty of Theology, and a Fellow of the Royal Historical Society. Dr. Griesel specializes in the Reformed tradition between the Reformation and the Enlightenment (c.1560–c.1750), particularly in the context of the Church of England, He is the author of *Retaining the Old Episcopal Divinity: John Edwards of Cambridge and Reformed Orthodoxy in the Later Stuart Church* (Oxford University Press, 2022) and the co-editor of *Reformed Identity and Conformity in England*, 1559–1714 (Manchester University Press, 2024).

The Rev. Dr. Benjamin Fischer (M.A. Emory; M.A., Ph.D., Notre Dame) is President of The Anglican Connection and is Rector of Christ the Redeemer Anglican Church in Nampa, Idaho. From 2008 to 2021, he served as Associate Professor of Medieval and Renaissance Literature at Northwest Nazarene University. Among his publications is *Being a Pastor: Pastoral Treatises of John Wycliffe* (2021).
